# NHS Wales — History Corner

Through various guises over the years SES has had a long association with the health estate in Wales. We have an extensive photograph library of hospital buildings as well as a traditional library. It's difficult to predict the future for hospital construction in Wales, but the past is more certain. A root around the archives identified the following, which hopefully you will find of interest. We hope to bring you more historical content in future issues. In this issue we look at...

## The origins of the Hamadryad Hospital

The control of diseases brought in on ships from far-flung countries was always a problem for the maritime trading centre of Cardiff. 171 people died in a cholera epidemic introduced by a sailor in 1854 and when another epidemic threatened the people of Cardiff in 1860s Dr Henry Paine, the Medical Officer of Health to Cardiff, secured an old Royal Navy 46-gun frigate - HMS Hamadryad - for use as a hospital for seamen. The idea was that it would help to prevent the spread of communicable diseases by ensuring that the patients were kept in the dock area rather than go ashore.

She was originally moored in East Bute Dock, but was soon relocated to the ominously named Rat Island where she did a roaring trade in helping sick seamen - 400 in her first year and by 1897 more than 10,000 men (and it was only men) were treated each year. Along with a wooden annex built to house further infectious patients in 1871, the Hamadryad served as the only isolation hospital in the area until a dedicated cholera hospital was opened on Flat Holm island in the 1890s.






"Hamadryad bowsprit, Pembroke Museum"

But the Hamadryad was already guite old when she was converted into a hospital, and it wasn't a universally approved solution to the need for more hospital services. There were accusations of refuse and filth from the ship becoming a nuisance on nearby mud banks, although these were strongly denied by Dr Paine. In 1905, after approximately 40 years' of service a permanent seamen's hospital, called the Royal Hamadryad Hospital, was opened on land close by and the ship was floated off her sandbank and towed to Appledore, where

she was broken up. All that remains are her bell and her bowsprit, which is housed in a museum in Pembroke Dock.
